Talitha Koum is a Christian Therapeutic Community based on a farm just north of Ipswich in beautiful Suffolk countryside. We aim to help women who have drug and alcohol addictions, giving them a rare and creative opportunity to change their lives for the better.

The carefully designed Talitha Koum programme offers the students, as they are known, a structured path from addiction to recovery. Choosing to live and work together for the good of the community helps create a sense of belonging for the students; a family feel with an identity and security, encouraging hope for the future.

After a professional assessment, the students will begin their new lives with the community and the daily routine of working together and studying will be established. They will join individually tailored courses which will take them through tried and tested programmes before addressing the challenging issues of understanding and avoiding relapse before moving into the wider community.

Although there are very serious issues which need to be dealt with on an emotional and physical level, the planned social enterprises also play their part. There's a real pride in planting and growing fruit, vegetables and flowers, pickling, jamming and selling the products and caring for the community's livestock. You may go to bed exhausted at the end of the day but can look forward to homemade bread and jam for supper and newly laid eggs for breakfast.

Life in the community won't be boring. There'll be plenty for the students to do, from art and music sessions to wood turning and IT, all designed to develop skills and self confidence.

The Talitha Koum project is run by experienced people with different professional skills. They're all keen to share their expertise, working with the students on the courses and social enterprise schemes. Some will live on site, sharing their Christian faith and bringing a positive focus to the day-to-day running of the project.

Our prime concern is to care for the students from the time they come to us and through their journey back into the wider community. We will maintain regular contact with them through our follow-up programme as long as they require it and they will always be welcome at Talitha Koum. Going back into the community will be difficult and they will need the support of individuals, churches and other organisations to help them find their feet. A friendly welcome, support and a heart of compassion can make all the difference to the students' chance of succeeding in living a normal life.
